All animal adoption contracts approved by All Paws Matter are subject to the following terms and conditions: The adopter agrees that the animal will be kept as a domesticated house pet. The adopter grants All Paws Matter the right to make periodic visits to the adopter's premises for the purpose of checking on the health and general welfare of the animal and to verify that the animal has been cared for according to the terms of this agreement. The adopter represents that he/she has never been subject to legal action for cruelty to or neglect of animals. The adopter further represents that he/she has never owned an animal which has been confiscated by an animal control officer or humane organization for violations of state or local animal control regulations or animal adoption agreements. The adopter understands that this animal is rescued. Animals are quarantined and fully vetted while in our care, and all known medical issues are disclosed, but additional veterinary attention may be needed at the owner's expense. The adopter agrees that All Paws Matter shall have the right of immediate possession of the animal if, in the judgment of All Paws Matter, the animal is receiving inadequate care, or is being improperly housed or handled. When an animal is returned/taken there will be NO REFUNDS OF THE ADOPTION FEE.
